### **Wireless Network Acceptable Use Policy**

**Christ Church Moreton grants you access to their WiFi network providing you agree to abide by this policy.**

#### **Introduction**

This policy outlines the standards which Christ Church Moreton requires all users of its electronic communications systems and equipment to follow.

#### **What is covered by the Policy?**

The use of the WiFi network supplied by Christ Church Moreton.

#### **Who is covered by the policy?**

This policy covers all individuals who wish to use the WiFi network supplied by Christ Church Moreton.

#### **Internet Use**

Users are reminded that their use of the Internet will be directly traceable to our Internet address.

We therefore ask you not to visit sites which are:

- Illegal under current law
- Defamatory, threatening or intimidatory or which could be classed as harassment
- Contain obscene, profane or abusive language
- Contain pornographic material whether in writing, pictures, films or video clips
- Contain offensive material regarding sex, race, religion or any disability or sexual orientation
- Infringe third party rights or otherwise unlawful or inappropriate

#### **Internet Content**

Christ Church Moreton reserves the right to block access to any site.

Christ Church Moreton will take reasonable steps to block any site that it deems inappropriate, however Christ Church Moreton cannot guarantee that all inappropriate content will be blocked. If you gain access to a site that you deem inappropriate close your web browser immediately.

Please be aware that Christ Church Moreton has a fair usage agreement with the broadband provider and services may be slowed if the connection is over used. For this reason please use the connection responsibly by not downloading large files or by streaming multiple videos via the wireless network. Usage will be monitored and this service withdrawn if public usage has a detrimental effect on the office speeds for which the broadband is primarily intended.

#### **Systems and Data Security**

Christ Church Moreton will provide Internet access via the wireless network and will undertake reasonable steps to ensure it is secure from unauthorised users. However no guarantee can be

made to this effect. You are responsible for your own anti-virus and anti-malware precautions. Christ Church Moreton will not be held responsible for any damage to your equipment whilst connected to its network.

You should not attempt to gain access to restricted areas of the network or to any password protected information without being duly authorised to do so

To gain access to the wireless network you will require the network password, this information is available on request from the office and will be changed periodically. You must not distribute this password to anyone.

**Monitoring and Compliance**

Christ Church Moreton reserves the right to protect its network and systems by recording user ACTIVITY but not CONTENT. That is to say no CONTENT will be captured but that a list of surfing activity maybe recorded;

- To ensure that the use of the system is legitimate and in accordance with this policy
- To comply with any legal obligation

If the use constitutes a criminal offence the information will be handed to the police.
